Pals for Pups, Inc.

This is an agreement made between Pals for Pups, Inc. (hereinafter called "facility") and the pet owner whose signature appears on the final page (hereinafter called "owner").

1. Owner is solely responsible for the supervision of their dog and whether their dog's participation in the activities set forth in the facility is an appropriate activity for their dog. Participating in the facility's activities is at your own risk and owner agrees to participate and hold harmless the facility for any injuries incurred.
2. It is strongly advisable, especially if you or your dog is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician or veterinarian before participating in any training or exercise activity.
3. Owner agrees that the pet shall not leave the facility until all charges are paid to the facility by the Owner. All charges incurred by Owner shall be payable upon pick-up of pet, or when billed by the Facility at the address listed on the Contract. The Facility shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding the pet at the Facility. If Owner does not pick up the pet within 30 calendar days after the day the pet was due to be picked up, the pet shall be deemed to be abandoned. At this time ownership will transfer to the Facility and the Facility will make future arrangements for the pet.
4. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
5. By signing this contract, Owner agrees that the Facility has full permission to use any picture, likeness, or image of pet for marketing purposes.
6. By signing this Contract and leaving pet with the Facility, Owner certifies to the accuracy of all information given about said pet and that the Facility's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$400 per animal boarded. The Owner further agrees to be solely responsible for any and all acts or behavior. Additionally, any medical bills incurred by staff as a result of said pet's behavior shall be the owner's responsibility.
7. If the pet becomes ill or if the state of the pet's health otherwise requires professional attention, the Facility, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the pet, and the expenses thereof shall be paid by Owner.
8. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of Owner and Facility.

Warning of Risk:

The activities provided by the facility are intended to provide a fun and rewarding experience for a dog and its owner/handler. There is always a risk of injury when doing physical activities and these activities are entered into at your own risk and owner is agreeing to allow their dog to also participate at their own risk. Certain inherent risks include the propensity of any dog to behave in a dangerous way that may result in injury to you, another person or dog. Other risks include, but are not limited to, the inexperience, negligence or irresponsibility of a dog owner/handler; the inability to predict a dog's reaction to sound, movements, objects, persons, or other animals; and actions by the dog due to fright, anger, stress, insect bites, or natural reactions such as jumping, pulling, resisting and biting. Other risks include the hazards associate with environmental and traffic conditions, acts of God, inclement weather, slip and falls, premises defects, equipment failure in instruction/supervision, and all other circumstances inherent to dog and/or outdoor activities.

Should you attempt to break up a dog fight or restrain a dog, including but not limited to your own dog, you may be attacked and severely mauled by your dog or the other dog, or attacked by another dog's owner/handler. In this regard, it must be recognized that it is impossible for Pals for Pups to guarantee your absolute safety.

Waiver and Release of All Claims

Read carefully and acknowledge each paragraph with your initials to accept responsibility. By using the facility, you are expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your dog might sustain as a result of participating in any and all facility activities.

____ Owner has read the above "Warning of Risk" section of this document and hereby accepts responsibility for their dog and their own behavior in said facility. Owner voluntarily agrees to assume the full risk of and responsibility for any injuries, damages, loss, liability, costs and expenses, regardless of severity, extent or amount that incurs due to their activities in this facility and their dog's activities in this facility.

____ Owner agrees to discharge Pals for Pups and its officers, directors, employees and agents from incurring any liability due to owner and dog's participation in facility activities. Owner agrees to indemnify and hold harmless Pals for Pups and its officers, directors, employees and agents from any and all claims or causes of action for damages, injury, loss, liability or expenses (including but not limited to attorney fees) which I may incur as a result of owner and dog's participation in facility activities.

____ Owner grants Pals for Pups and/or its selected agents full power of decision concerning the care and well-being of our dog(s). Should any medical emergency arises, it is agreed that Pals for Pups and its selected agents can and will make any needed decision concerning medical treatment and choice of care giver.

____ Owner agrees that by signing below, they accept exclusive and sole responsibility (financial and otherwise) for these and all other risks and release Pals for Pups of all liability, no matter the cause.

I HAVE READ AND FULLY UNDERSTAND THE ABOVE IMPORTANT INFORMATION, WARNING OF RISK, ASSUMPTION OR RISK AND WAIVER AND RELEASE OF ALL CLAIMS. IF REGISTERING ON-LINE OR VIA FAX, YOUR ON-LINE OR FACSIMILE SIGNATURE SHALL SUBSTITUTE FOR AND HAVE THE SAME LEGAL EFFECT AS AN ORIGINAL FORM.
